CAI-CLAC Legislative Update



The Legislature returned to Sacramento to start the second year of the Legislative Session on January 3rd.

On January 10, the Governor will submit the 2024-25 budget to the Legislature for consideration, and it's expected to show a \$68 billion deficit. Many in the current Legislature have never dealt with a deficit of this size, due to term limits. Notwithstanding the lack of experience, the Legislature is required to send a balanced budget to the Governor by June 15.

While there will be considerable focus on the budget, other legislation will happen. Your advocacy team is currently meeting with potential authors on our 2024 priorities, which include extending the deadline for balcony inspections, cleaning up AB 1458 dealing with reduced quorums, and electronic balloting for elections. The deadline for new legislation to be introduced is February 16.
